



**SACRAMENTO AREA COUNCIL OF GOVERNMENTS**

**RESOLUTION NO. 30 – 2024**

**APPROVING THE COUNTY OF SACRAMENTO’S AMENDED TRANSPORTATION DEVELOPMENT ACT CLAIM FOR FISCAL YEAR 2023-2024 OF \$2,657,967**

**WHEREAS**, the County of Sacramento has submitted FY23-24 amended claim for Local Transportation Funds (LTF) reducing funds for Ped and Bike projects to \$750,233 and SACOG Planning Fees to \$40,513 following revised LTF revenues by Sacramento County Department of Finance based on estimate sales revenues and;

**WHEREAS**, FY23-24 State of Good of Repair (SGR) claimed amount is unchanged at \$47,980 and;

**WHEREAS**, the County requested prior years’ unclaimed LTF funds as follows: -FY19-20 (\$571,723), FY20-21 (\$287,420), FY20-21 (\$1,000) and FY22-23 (204,591) including \$5,941 in SACOG’s Planning fee;

**WHEREAS**, the County requested prior years’ unclaimed State Transit Assistance (STA) as follows: -FY18-19 (\$19,080) and FY 19-20 (349,819) and FY 22-23 unclaimed State of Good Repair funds in the amount of \$1,531 under the provisions of the Transportation Development Act. The following table shows each fund amounts and purposes for each fiscal year:

**WHEREAS**, such claim is consistent with State Law, with Guidelines adopted by the Board and with the approved apportionment for FY18-19, FY19-20, FY20-21, FY21-22, FY22-23, and FY23-24; and

**WHEREAS**, the Board Resolution No. 17-2023 on February 16, 2023, found that there are no unmet transit needs that are reasonable to meet in the Unincorporated Areas of Sacramento County outside of the Sacramento Regional Transit District.

**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby makes the following findings in accordance with Subchapter 2.5, Article 5, Section 6754 of the Transportation Development Act:

1. The County of Sacramento’s proposed expenditures are in conformity with the Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS).
2. The level of passenger fares and charges is sufficient to enable the County of Sacramento to meet the fare revenue requirements of the Public Utilities Code when blended with other transit agencies in Sacramento County as allowed by AB432.
3. The County of Sacramento is making full use of federal funds available under the Urban Mass Transportation Act of 1964, as amended.
4. The sum of the County of Sacramento’s allocations from the state transit assistance fund and from the local transportation fund does not exceed the amount the claimant is eligible to receive during the fiscal year.
5. Priority consideration has been given to claims to offset reductions in federal operating assistance and the unanticipated increase in the cost of fuel, to enhance existing public transportation services, and to meet high priority area wide public transportation needs.
6. The County of Sacramento has made a reasonable effort to implement the productivity improvements recommended pursuant to Public Utilities Code Section 99244.
7. The County of Sacramento is not precluded by any contract entered into on or after June 28, 1979 from employing part-time drivers or from contracting with common carriers of persons operating under a franchise or license.

8. The County of Sacramento has submitted the certification required by the Department of the California Highway Patrol verifying that the operator is in compliance with Section 1801.1 of the Vehicle Code.

9. The County of Sacramento is in compliance with the eligibility requirements of Public Utilities Code Section 99314.6.

**BE IT FURTHER RESOLVED** that the Board hereby approves a claim which includes Local Transportation Funds, State Transit Assistance and State of Good of Repair for a total claim of \$2,657,967 and authorizes the forwarding of funds to the County of Sacramento in proportion to funds received from the State.
