



**SACRAMENTO AREA COUNCIL OF GOVERNMENTS
RESOLUTION NO. 101 – 2023**

**APPROVING THE CITY OF WEST SACRAMENTO'S AMENDED TRANSPORTATION
DEVELOPMENT ACT CLAIM FOR FISCAL YEAR 2023-2024 CLAIM OF \$6,709,506.08**

WHEREAS, the City of West Sacramento has submitted a claim for Fiscal Year (FY) 2023-2024 Local Transportation Funds (LTF) for \$2,750,602.08 and;

WHEREAS, staff is amending the Public Utility Code (PUC) for the requested funds on Bus Shelter & Harbor Yard and the VIA-On Demand Service to reflect the correct PUC for the purpose and;

WHEREAS, the City of West Sacramento will continue to fund VIA, an on-demand micro transit program under the provisions of the Transportation Development Act and purposes as follows:
