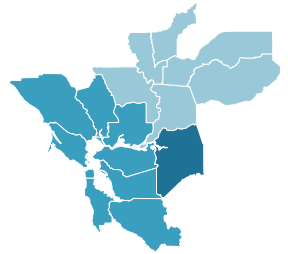

RE: Restore Budget Funding for Regional Early Action Planning Grants of 2021 (REAP 2.0)

Dear President pro Tempore McGuire, Speaker Rivas, Chair Wiener, and Chair Gabriel:

The Megaregion Working Group respectfully urges the Legislature to reject the \$300 million cut to the Regional Early Action Planning Grants of 2021 (REAP 2.0) included in Governor Newsom's 2024-25 January Budget proposal. The \$300 million rescission eliminates half of a \$600 million investment to advance the implementation of adopted regional plans by funding planning and infrastructure investments that accelerate infill housing and reduce vehicle miles traveled (VMT).

The Megaregion Working Group is a partnership of twelve Northern California elected officials, including four representatives each from the Metropolitan Transportation Commission (MTC) in the Bay Area, the Sacramento Area Council of Governments (SACOG), and the San Joaquin Council of Governments (SJCOG). The Megaregion, which includes 16 counties and 136 cities, has a total population of nearly 11 million people and stretches from the Bay Area and Central Valley to the Sierra Nevada Foothills. The Working Group's mission is to tackle shared transportation and housing challenges and better connect the people and economies of the Megaregion.

REAP 2.0 is vital to California's strategic investments toward a more sustainable, resilient, and inclusive future. REAP 2.0 will accelerate progress toward our state housing goals and climate commitments through a strengthened partnership between the state, its regions, and local entities.

This unprecedented retraction in fully committed funding for REAP 2.0, SACOG's Green Means Go, and MTC's Plan Bay Area's Growth Framework implementation, will result in cancellations or delays in critical infill housing infrastructure that is well underway. Please protect funding for REAP 2.0 by rejecting the Governor's January proposal.
