RESOLUTION NO. 44 – 2024

**APPROVING THE CITY OF ISLETON’S TRANSPORTATION DEVELOPMENT ACT CLAIM
FOR FISCAL YEAR 2024-2025 FOR \$246,973**

WHEREAS, the City of Isleton has submitted a claim for Fiscal Year (FY) 2024-2025 Local Transportation Fund (LTF) for \$44,426, including \$935 in Pedestrian and Bicycle funds and \$9,076 of State Transit Assistance Fund (STA) and;

WHEREAS, the City is requesting unclaimed funds from prior years as shown on the claim table below under the provisions of the Transportation Development Act for the amounts and purposes as follows:

WHEREAS, such claim is consistent with State Law, with Guidelines adopted by the Board, and with approved apportionments for FY11-12, FY12-13, FY13-14, FY14-15, FY15-16, FY16-17, FY17-18, FY21-22, FY22-23, FY23-24 and FY24-25; and

WHEREAS, the Board Resolution No. 12-2023 on February 16, 2023, the Board found that there are no unmet transit needs that are reasonable to meet in the City of Isleton and

NOW THEREFORE, BE IT RESOLVED, that the Board hereby makes the following findings in accordance with Subchapter 2.5, Article 5, Section 6754 of the Transportation Development Act:

1. The City of Isleton's proposed expenditures are in conformity with the Metropolitan Transportation Plan and Sustainable Communities Strategy (MTP/SCS).
2. The sum of the City of Isleton's allocations from the state transit assistance fund and from the local transportation fund does not exceed the amount the claimant is eligible to receive during the fiscal year.

BE IT FURTHER RESOLVED, that the Board hereby approves the requested LTF for \$218,572 and STA for \$28,401 for a total claim of \$246,973 and authorizes the forwarding of funds to the City of Isleton in proportion to funds received from the State.
