RESOLUTION NO. 34 – 2024

APPROVING THE CITY OF ELK GROVE’S AMENDED TRANSPORTATION DEVELOPMENT ACT CLAIM FOR FISCAL YEAR 2023-2024 IN THE AMOUNT OF \$929,743

WHEREAS, the City of Elk Grove has submitted an amended claim for FY 2023-2024 Local Transportation Funds (LTF) of \$219,719 following a reduction in LTF sales revenues as revised by Sacramento County and;

WHEREAS, the City of Elk Grove previously requested unclaimed funds for Bicycle and Pedestrian projects from FY19-20 (\$154,898), FY20-21 (\$145,091), FY21-22 (\$190,335), and FY22-23 (\$219,700) under the provisions of the Transportation Development Act for the amounts and purposes as follows:
