CALL TO ORDER: Vice Chair Samayoa called the meeting to order at 10:00 a.m.

**Public Comment:** Jeffery Tardaguila, an advocate for Disability Organizing Group for Initiating Total Equality (DOGFITE), provided public comment regarding the location of the next scheduled board meeting and its workshop.

The Transportation Committee adjourned and the SAFE Committee convened at 10:04 a.m. The SAFE Committee adjourned, and the Transportation Committee reconvened at 10:07 a.m.

**1. Approve Minutes from the April 4, 2019, Transportation Committee Meeting**

Upon motion by Vice Chair Slowey, seconded by Director Saragosa, the Transportation Committee unanimously approved the minutes as submitted.

**2. Approve Contract with the City of Rancho Cordova for Autonomous Shuttle Pilot Project**

Upon motion by Director Saylor, seconded by Director Veerkamp, the Transportation Committee unanimously recommended that the board authorize the executive director to negotiate and execute a contract not to exceed \$90,000 with the City of Rancho Cordova for an autonomous shuttle pilot that will be launched by a private-sector vendor, Local Motors.

Jeffery Tardaguila, an advocate for Disability Organizing Group for Initiating Total Equality (DOGFITE), provided public comment about the utilization of the accessibility tool.

**3. Approve One-Year Extension of the SACTrak Database Services Contract with EcoInteractive, Inc.**

Upon motion by Director Jennings, seconded by Director Veerkamp, the Transportation Committee unanimously recommended that the board authorize the executive director to execute a one-year extension on the contract with EcoInteractive, Inc. through June 30,

2020.

**4. Support for Applicants to the 2019 Federal Better Utilizing Investments to Leverage Development (BUILD) Program**

Upon motion by Vice Chair Slowey, seconded by Director Peters, the Transportation Committee unanimously recommended that the board authorize SACOG staff to provide support to any project sponsor in the region seeking federal BUILD funding as long as the proposed project is consistent with the Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS).

Furthermore, the Transportation Committee requested that staff provide an updated list to the board before taking action during the next board meeting.

Mike Garabedian, of the Sierra Club Placer Group, provided public comment in opposition against the Amoruso Ranch Specific plan.
