These improvements increased total service hours on the route by 8,820.0 and increased service miles by 115,781.40 annually. Route 68 provides bus service to the following communities Arden-Arcade, Midtown, Oak Park, and North Laguna, starting at Arden Fair Mall and ending at Consumnes River College, connecting housing with education, shopping, community services and light rail services.
