Re: 2021 Flex RSTP – Letter of Understanding between MTC and SACOG

Dear Ms. Lam:

This letter of understanding constitutes an agreement between the Metropolitan Transportation Commission (MTC) and the Sacramento Area Council of Governments (SACOG) for an exchange in “Flex” Regional Surface Transportation Program/Surface Transportation Block Grant Program (Flex RSTP) apportionment. “Flex” RSTP refers to the funds suballocated to metropolitan areas that can be obligated anywhere in the state.

This letter is to formalize the exchange of \$600,000 in Flex RSTP apportionment from MTC to SACOG in Federal Fiscal Year (FFY) 2021. SACOG shall repay the loan by providing MTC the same amount of apportionment loaned, \$600,000 in Flex RSTP apportionment in FFY 2022.

This letter of understanding sets forth MTC and SACOG’s agreement for use of the identified RSTP apportionment, and requests that Caltrans adjust each agency’s apportionment as appropriate. This applies to obligations through September 30, 2021, only.

Please provide MTC and SACOG written confirmation that this exchange of apportionment is allowed and will be supported by Caltrans. We appreciate this opportunity to exchange apportionment and support our transportation partners.
