Subject: Federal Policy Monthly Report

House Appropriations Bill

The House passed the FY23 funding bill, which included increased funding for several transportation programs. There is still considerable work to be done before a final appropriations bill becomes law. The Senate must release their bills and a topline number must be agreed upon. This summary only reflects what has been passed by the House – we will watch for topline numbers from the Senate.

The House FY23 funding bill includes a twelve percent increase in total funding compared to FY22, including a \$2.4 million increase in resources for DOT, with a total of \$105.4 billion in DOT funding.

- \$775 million in national infrastructure investments, including RAISE discretionary grant program
- \$646 million in Transit Infrastructure Grants for agencies to purchase reduced emissions busses and to support clean transit programs and new smart mobility grants
- \$3 billion in Capital Investment Grants (CIG) to create new transit routes, including \$600 million to assist certain transit agencies with gaps in their full funding grant agreements
- \$555 million for federal-state partnership grants to support passenger rail projects
- \$630 million for CRISI grants for rail safety and infrastructure projects
- \$477 million for Highway Infrastructure Grants, including \$100 million for Safe Streets and Roads for All, \$100 million for Active Transportation Infrastructure, and \$55 million for Healthy Streets

Additionally, the THUD bill included 1,827 earmarks for a total \$3.7 billion for airport, highway, and transit projects. (Attached list)

FHWA Nominee

President Biden nominated Shailen P. Bhatt to be the Administrator of the Federal Highway Administration. Bhatt was most recently Senior VP of Global Transportation Innovation and Alternative Delivery at AECOM. He also served as the Executive Director of the Colorado Department of Transportation, Cabinet Secretary of the Delaware Department of Transportation, as a presidential appointee at the U.S. Department of Transportation, and worked as the CEO

of the Intelligent Transportation Society of America. His nomination is moving through the Senate.

GHG Reduction Proposal

FHWA announced a proposed rulemaking for states and municipalities to track and reduce greenhouse gas (GHG) emissions. The new rule would:

1. Establish a national framework for tracking state-by-state progress by adding a new GHG performance management measure to the existing FHWA national performance measures to help states track performance and make more informed investment decisions.
2. Create a flexible system under which State DOTs and MPOs would set their own declining targets for on-road greenhouse gas emissions from roadway travel on the National Highway System.

The proposed rule would require State DOTs and MPOs to report biennially on their progress in meeting the declining targets they establish and require FHWA to assess significant progress toward achieving those targets. FHWA is accepting comments on the proposed rule through October 13, 2022.

Buy America Waiver for Mini-Vans Proposed

The Federal Transit Administration has proposed a partial 2-year Buy America waiver for passenger vans and minivans. Under the proposed partial waiver, agencies may procure passenger vans and minivans or procure services that use those vehicles so long as final assembly of those vehicles is in the United States and the engine is from the US (new requirement). Agencies often use these vehicles in vanpool, micro-transit, and demand response projects. This waiver comes nearly 3-years since the last waiver expired. If the proposed waiver is made final, agencies providing the services above will be able to acquire services or vehicles immediately.
